Location: Roger Milliken Center, 920 Milliken Road, Spartanburg, SC. From Spartanburg, Greenville, Columbia and Asheville – 85 to Exit 69 (I 85 North Business) then take Exit 5B. From Charlotte – 85 take Exit 77 (I85 Business) then take Ext 6. Take a left over the bridge. Follow USATF signs to parking area. Using Highway 26 to travel exit 19B and follow above. **Parking only in parking lot area. No parking on any grass area is permitted.**

ENTRY FEES: \$10.00 for each participant.

Awards: Awards will be given to the top three finishers in each division.

The Course: The entire course is grass surface. Spikes may be useful on the hills or if the course is wet. The course will be closed at 8:30 a.m. No one will be allowed on the course for warm up after this time. There is plenty of area for warm up in the adjoining field areas. No dressing facility or public water is available.

Late Registration: Registration postmarked after November 3, 2007 must contain an additional \$3.00 late registration fee per athlete or they will be returned. No package received after November 6th will be accepted.

Late Entries on Race Day: The race day entry fee will be \$15.00 per athlete (late fee included) Cash only will be accepted. All athletes must be current SC USATF members. Note that any memberships purchased after November 1, at the price of \$29.95, are for 2007 and 2008.

Race Day Membership: Race day membership will be available for the annual fee of \$29.95 during the day of the meet. Cash only will be accepted..
